

## BID NOTICE

INVITATION TO BID FOR THE FOLLOWING CONSTRUCTION WORKS AT DUBREUIL:

- (i) BOUNDARY WALLS AND GATES; AND
- (ii) INTERNAL ROAD NETWORK.

### 1. INTRODUCTION

The National Empowerment Foundation (NEF) invites bids from eligible and qualified bidders for the following construction works at Dubreuil:

- (i) Boundary Walls & Gates - NEF/22 of 2011
- (ii) Internal Road Network - NEF/23 of 2011

**Note: Bidders may quote for either project (i) or (ii); or both projects.**

### 2. ELIGIBILITY

This "Invitation to Tender" applies to Building Contractors having the technical capacity, resources and sound financial situations.

### 3. SCOPE OF WORKS

The works comprise:

- i. The construction of Boundary Walls & Gates for 23 individual houses at Dubreuil. Each house is of an area of approximately 30 sqm. Boundary Walls consist of 150mm thick block wall and approx. 430mm above ground level, chain link fencing, metal gate and morefully described in the Bid document.
- ii. The construction of Internal Road Network at Dubreuil of approx. 5.5m wide with road reserves of 1.0m wide on both sides and morefully described in the Bid document.
